

Privacy Policy

In fulfillment of the established in the Organic Law 15/1999, of December 13, of Protection of Information of Personal Character, it puts in knowledge of the users of this web site on the following thing:

1. The information that the users facilitate to Fincas B will be incorporated into a database of the one that is titular and responsible "Fincas La Corredera Servicios inmobiliarios S.L.", with head office in Corredera de San Fernando nº 19 - bajos, 23400 ÚBEDA (Jaén - Spain) provided with CIF: B-23.537.418, and inscribed in the Mercantile Record of Jaén (sheet 119, volume 346, inscription 1^a, sheet J-12.893).
2. When for the access to certain contents or for the utilization of some service it is necessary to facilitate information of personal character, the users will guarantee his veracity, accuracy, genuineness and force. In this respect, it will be an obligation of the users to keep updated the information of such form that correspond to the reality in every moment.

Fincas B under any circumstances sell or rent your personal information, and only provide or make available to a third party, for the purposes stated above, with the prior consent of the user, which means consent granted if the user says nothing the matter within fifteen days from that in which it was requested. The user can deny or revoke its consent by sending an e-mail to admin@seguros-barba.com.
7. Users can exercise at any time, the rights of access, rectification, cancellation and opposition of their personal data.
